

CERTIFICATION OF INCORPORATION

ENTERNATIONAL SOCIETY FOR KRISHNA CONSCIONSNESS OF THE BAY AREA, SHE.

ME. THE UNDERSIGNED, in order to form a non-profit, non-stack corporation for the purposes hereinefter stated, under and pursuant to the provisions of the Germanal Mon-Profit Corporation Law of the State of California, do herebye cortify as follows:

FIRST: The name of the proposed corporation (hereinafter referred be as the "Corporation") is :

INTERNATIONAL SOCIETY FOR KRISHMA CONSCIOUSNESS OF THE BAY AREA, INC.

SECOND: The principal office for the transaction of the business of the Corporation is to be located in the County of Alameda, in the State of California.

THIRD: It is declared that His Divine Grace A.C. Bhaktivedants Soum?

Problemade is the Founder-Amerys of the International Society for Brishna Consciousness of the Bay Area. He shall be the supreme power with respect



to all matters of the Seciety, and that status shall not be occupied by or shared with any other individual, either during his lifetime, or after his death. His same and title must appear on all documents, letterheads, publications and buildings of the Society or Corporation.

FOUNTH: The Corporation is organized and shall be operated exclusive ly for the religious, charitable, literary and educational purposes, within the meaning of Section 501 (C) (3) of the Internal Revenue Code of 1954, and the regulations promulgated thereunder, and particularly for the following purposes:

- (a) To systematically propagate spiritual knowledge to society at large and to educate all peoples in the techniques of spiritual life in order to check the imbalance of values in life in order to check the imbalance of values in life and to achieve real unity and peace in the world.
- (b) To propagate a coneciousness of krishna as it is revealed in the 
  Bhagavad-cita As It Is, Srimad Rhagavatam, and other authorized 
  Vedic literatures as translated and presented by His Divine Grass 
  A.C. Shektivedanta Swami Prabhupada.



- (c) To bring the numbers of the Society 'sgether with each other and nearer to Krishne, the prime entity, and thus to develop the idea, within the numbers, and humanity at large, that each soul is part and parcel of the quality of Godheed (Krishne).
- (d) To teach and encourage the Sankirtan Movement, congregational chanting the holy name of God, as revealed in the teachings of Lord Sri Caitanya Mahaprabhu.
- (e) To erect for the members, and for society at larne, a holy place transcendental pastimes, dedicated to the personality of Krishna.
- (f) To brino the members' closer together for the nursose of teaching a simpler and more natural way of life.
- (a) With a view towards achieving the aforementioned purposes, to publish and distribute periodicals, mesazines, books and other wellings.
- (h) To receive, administer and distribute funds, and to do all atmost takings necessary and proper in furtherance of the above stated purposes.



(1) To recognize the Founder-Acarys of the International Society for Krishma Consciousness, His Divine Grece A.C. Shaktivedanta Seami Prabhupada, as the supress authority in all metters of the Corporation, or Seciety: His Fersonal representatives, the Governing Body Comission, as his authorized equats or executors, appointed by him according to the document <u>Directions of Management</u>, dated July 28, 1970.

FIFTH: The Corporation shall neither have nor exercise any nower, nor shall it engage directly or indirectly in any activity, that would invalidate its status (a) as a corporation which is exempt from federal income taxation as an organization described in section 501 (c) (3) of the Internal Revenue Code of 1954 or (b) as a corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1954.

SIXTM: The Corporation shall not be operated for the purpose of conduction a trade or business for profit, and no part of the net earning or the assets of the Corporation shall insure to the benefit of or be distributable to any member or other individual, nor shall any of such net earnings or assets of the Corporation be used other than for the purposes of the Internal Revenue Code of 1954, as the members of the Corporation, by majority vote thereof, shall determine, and none of such assets shall be distributed to, or divided among.

The property of this Corporation is irrorecably dedicated to charitable or religious purposes, and the unlikely even of liquidation, dissolution or abandonment of the owner, after providing for the debts and abligations thereof, - the remaining assets will not inure to the benefit of any private person but will be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for charitable or religious surposes and which has astablished its tex exampt status under Section 501 (C) (3) of the Internal Revenue Code.

SEVENTH: The directors of the corporation shall have the nower, either directly or indirectly, either alone or in conjunction with others, to do any and all lawful acts and things and to emage in any an all lawful activities which may be necessary, useful, suitable, desirable, or proper for the furtherance, accomplishment, fostering, or attainment of any or all of the surposes for which the Corporation is organized. The Corporation shall exercise its powers in compliance with the exempt purposes of creanizations set forth in Section 501 (c) (3) of the laternal Revenue Code and its Regulations as the same may active or as they may be hereafter areased from time to time.

Elegant The Corporation's operations shall be conducted principally wighin




the United States of America; subject to the Tans of the State of California the Corporation also may conduct operations in Foreign countries.

WINTH: Except as otherwise provided by law, or in this Certificate, or in any Sy-Law of the Corporation, all of the affairs of the Corporation shall be managed and all of the powers of the Corporation shall be exercised by the Goard of Directors. However, the nower to make, alter, amend, chance, add to or repeat the Sy-Laws of the Corporation shall be reserved to the members of the Corporation. The number of directors and the manner of their election shall be as provided for in the Sy-Laws, and unless otherwise provided for therein, the election of directors need not by ballot.

TENTH: The Cornorat ion shall not have authority to issur any capital stock. The conditions of membership in the Cornoration, the rights and obligations of its members and the classification of members, if any, shall be as provided in the Sy-Laws.
